Subject: - Complaint against Renowned Buildtech Pvt Ltd, Lotus Villas Sector-1 Residents Welfare Association and Noida Power Company Ltd which includes but is not limited to illegally discharging about 10 lakhs litre daily of Sewer waste water into water drainage nalla of GNIDA / Jalpura village; forcefully deducting non-electricity charges in violation of tariff orders and threatening to disconnect NPCL electricity on non-payment; forcefully demanding as a right money for completion of builder work, construction and maintenance of temple places, building of decorative / beautification drive, expense of about Rs.4 lakhs per year for dumping sewage in water drainage nalla, purchase of diesel, spare parts and other expenditure of two diesel generator set (we not opted for DG Set), hiring of RFID barrier for Rs.2 lakhs per annum, etc; wrongly & unfairly selling of house / Villa 176 by deliberately representing / insisting and forcefully claiming maintenance as it is of 1,365 Sq feet but it is 90.28 Sq meter only in registered sales deed; in correspondence, submissions in various legal forums, letter head, etc misrepresenting Mohalla Lotus Villa as Lotus Villa(s) Society to illegally gain control over its parks, roads, vacant spots, etc and make loss of crores of rupees of revenue to the central government / state government / local government; and till perpetuity get the right to forcefully demand and deduct money from Lotus Villa 176; etc

Please kindly inform if Gautam Budh Nagar as per law has authorized any third party apps from Google play / Apple / Windows store to mandatorily insist and collect personal information / data from persons / family members who are coming and going from their own freehold house in any Mohalla / Mohalla Lotus Villa at Gautam Budh Nagar.
